1. Bungal Municipality Office **has received a grant** from **GoN** towards the cost of Construction of Khiratadi Primary Hospital and intends to apply part of the funds to cover eligible payments under the Contract. Bidding is open to all eligible as per Section V of bidding document..
2. Bungal Municipality Office invites electronic bids from eligible bidders for the construction of Construction of Khiratadi Primary Hospital under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: [ **Nrs 23,40,00,000/- ( Two Hundred Thirty Four Million) ]**
  - Minimum Work experience of similar size and nature: [ **One (1) Contract of RCC Framed Building Construction Project within the last ten (10) years with a value of at least Nrs. 15,60,00,000/- ( One Hundred Fifty Six Million) Including VAT** ]
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
  4. 6. Pre-bid meeting shall be held at Bungal Municipality Office Khiratadi, Bajhang at 08-Mar-2021 (2077/11/24) at 12:00 Noon.
7. Electronic bids must be submitted to the office Bungal Municipality Office Khiratadi, Bajhang through PPMO website [www.bolpatra.gov.np](http://www.bolpatra.gov.np). on or before 12:00 Noon on 18-Mar-2021 (2077/12/05). Bids received after the deadline will be rejected.



8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 18-Mar-2021 (2077/12/05) at the office of Bungal Municipality Office Khiratadi, Bajhang. Bids must be valid for a period of 120 ( One Hundred Twenty ) Days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of 50,00,000/- ( Fifty Lakh Only ), which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. Bungal Municipality Office, Khiratadi, Bajhang reserve the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
11. In Case of Discrepancy or error in Tender notice, bid document and other document of Construction of Khiratadi Primary Hospital projects reserves right to amend, correct at any time. Such amendment and correction shall be published in the national daily newspaper, notice board of the Bungal Municipality Office, Khiratadi, Bajhang.
